


Context and objectives



Key action 1: Mobility

Erasmus+ project logic and structure



- In KA1, a school is at the center of the project or accreditation
- The purpose of the project is to improve the school.
- Objectives are defined in the application; partners are decided later.

Key action 2: Cooperation



- In KA2, an idea is at the center of the project.
- Project idea must be more than "just mobility"
- The purpose of the project is to make that idea a reality through contributions from the different partners (schools, but not only schools)
- Partners are listed in the application as an integral part of the proposal.



Cooperation and exchange in school education: state of play

Advantages:

- High interest in and motivation for Erasmus+; consistent and resilient
- Accreditations: operational basis for mainstreaming mobility; existing involvement of school authorities as leaders of mobility consortia

Challenges:

- Limited resources, experience and mandate of schools to run cross-border projects
- Restrictive regulation on staffing, finances
- Differences between school education systems across the EU
- Systemic challenges (teacher shortages, larger variety of tasks and demands)

A targeted and inclusive action for high impact in the school education sector

Partnerships between school authorities (national, regional and local) and schools across multiple countries, led by school authorities

Build on the proven benefits of Erasmus+ learning mobility and cooperation, synergies with existing projects and experience

Open to EU MS and third countries associated to the programme – managed by National Agencies

Focus on building capacity and implementing innovative practices in a sustainable (beyond the project duration) and systemic (beyond the participating schools) manner

Expected impact: will lead to changes in the way the participating organisations operate (i.e. their practices, policies and procedures), with due respect to subsidiarity

Eligibility criteria



Eligible applicant organisation

The applicant organisation (coordinator) must be a local or regional school authority, or a school coordination body.

The applicant organisation applies on behalf of all participating organisations.

An organisation can coordinate only one application per application deadline.



Eligible partner organisations

Schools providing general education at pre-primary, primary or secondary level ("category 1")

Local and regional school authorities or school coordination bodies ("category 2")

Associations of teachers, school leaders and school education staff, parent associations and other stakeholders in the school education system ("category 3")

- □ Eligible organisations in each country will be defined by the competent National Authority and published on the website of the relevant National Agency
- The same definition of eligible local and regional school authorities (category 2) applies to project coordinators and project partners
- ☐ The National Authority may decide not to define any eligible organisations under category 3 if there are no relevant organisations in the national school education system



Number and profile of participating organisations

Programme Guide:

Each partnership must include at least six participating organisations.

In the country of the applicant organisation and in at least one other country, the following organisations must be involved:

- at least or school coordination body; one local or regional school authority
- at least two schools providing general education at preprimary, primary or secondary level, including organisations providing early childhood education and care

- + Optionally further authorities, schools or third organisations

Additional countries are optional.

There are no minimum requirements for them in terms of number or type of organisations



Participating countries

Coordinators and partner organisations must be established in an EU Member State or in a third country associated to the Programme.



What will the projects do: two key strands

Improving the quality of learning and teaching at school

Trigger innovation in school education through exchange of know-how and best practices across borders:

- Designing innovative teaching and learning formats for basic skills, EU values, language learning, etc.
- Collaborative teaching, including virtual components
- Peer-learning and mentoring, including job shadowing for teachers, school leaders and policy makers
- Pooling resources at local and regional level to better manage teacher substitution and shortages

Capacity building for cross-border cooperation in school education

Strengthening the schools' ability to engage in cross-border projects and removing obstacles to mobility, including:

- Establishing regional mobility coordinators, offices, support points or similar
- Standardising procedures and quality requirements
- Testing 'mobility windows' in the school calendar
- Improving recognition of learning outcomes
- Improving recognition of teachers' project work
- Project management training for school staff

Eligible activities / tasks

- Projects must implement at least three tasks, including at least one from each of the two strands.
- A project can select a maximum of 10 tasks.
- Each task will correspond to a work package in the project application.
- In addition, there are two mandatory work packages: "Project management" and "Plan for long-term impact".

Minimum project structure:

Work Package 1

Project management - mandatory

Work Package 2

Task 1 – chosen by project partners

Work Package 3

Task 2 – chosen by project partners

Work Package 4

Task 3 – chosen by project partners

Work Package 5

Long-term impact plan - mandatory

Eligible project expenses

Costs linked to the implementation activities and tasks, for example:

- testing specific learning programmes
- co-teaching methods
- staff training
- travel costs for meetings between project partners
- etc.

"Erasmus+ learning mobility activities" are educational, strategic, transnational and structured (documented) mobility activities. Learning mobility should not be confused with other reasons for travelling abroad as part of an Erasmus+ project.

Budget: Single lump sum of 400 000 EUR

The application must include the distribution of the grant amount among participating organisations and per work package.



Award criteria



Award criteria

To be considered for award, applications must pass the following thresholds:

- At least 70 out of the total 100 points, and
- At least half of the maximum score points in each of the four award criteria categories

Award criterion	Maximum points	Pass threshold
Relevance	15	8
Quality of project design	30	15
Quality of the partnership and the cooperation arrangements	20	10
Impact	35	18





Connect your project to reality – give examples of what you are trying to solve or improve.





Partner finding

You need **reliable** partners with whom you can work over **four years** to develop the project idea, write the application, implement the project, do the reporting, and follow-up.

Focus on needs and impact you want to create and pick partners based on this, not the other way around.

Explore existing partnerships or connections (Erasmus+, partner regions / twin cities / schools) for their potential.

Your National Agency is there to support you!

- Dedicated online networking / speed dating events
- Exchange with other National Agencies
- Pool of interested organisations



Application Form



The application form will guide you through a series of questions that make you reflect on:

- Why do you want to apply?
- With whom do you want to work? Why with them?
- What value does your project idea hold for you and for others?
- What do you want to achieve? What will be the results and impact?
- How will you get there? What steps will you have to make?



Tips for preparing an application

- Understand eligibility criteria
- Use award criteria as your guidance
- Find partners that share your challenges and interests. Work as a team!
- Think about the long-term changes you want to create make your plan going backwards from there
- Put a clear structure to your work packages
- Once you have a first draft, work on coherence between different parts
- Don't wait start now!
